Terms of Service

SYMANTEC CORPORATION AND/OR ITS AFFILIATES (“SYMANTEC”) IS WILLING TO PROVIDE THE SERVICES (DEFINED BELOW) OFFERED ON THIS WEBSITE TO YOU AS THE INDIVIDUAL, THE COMPANY, OR THE LEGAL ENTITY THAT WILL BE UTILIZING SERVICES (REFERENCED BELOW AS “YOU” OR “YOUR”) ONLY ON THE CONDITION THAT YOU ACCEPT THIS TERMS OF SERVICE (“TERMS OF SERVICE”). 1. License Grant. Subject to and conditioned upon Your compliance with this Terms of Service, Symantec grants You a non-exclusive, non-transferable, nonsublicensable, limited right and license to (i) access the service offered to you on this website for internal business purposes only, to obtain installation and performance enhancement services for Symantec products for which you have a license (“Service”); (ii) use the data collector provided to You by Symantec as part of the Service (“Software”) to collect data related to the Symantec product(s) for which You have a license and Your computer system environment (“Environment”) solely to enable Your use of the Services; and (iii) download the VCS agent software (“VCS Agent”) and use the VCS Agent in accordance with the license agreement governing the VCS Agent..
2. License Restrictions. You may not (and You may not permit anyone else to) copy, modify, create a derivative work of, reverse engineer, decompile or otherwise attempt to extract the source code of the Software or any part thereof, unless this is expressly permitted or required by law. Any data collected using the Software (i) may only be used to enable your use of the Service for your internal business purpose, (ii) may not be used for the benefit of a third party and (iii) may not be published.
3. Data Privacy. Any information collected by the Software will be maintained in a secure manner, and will not be correlated with any other personally identifiable information. Symantec reserves the right to cooperate with any legal process and any law enforcement or other government inquiry related to Your use of the Software and/or Service. Symantec may disclose the collected information relevant to a court subpoena or other legal process, or to a law enforcement or other government investigation.

Any information submitted by You to Symantec to establish Your right to receive the Services and/or to use the Software shall be used by Symantec for the purpose of license administration, and shall be kept in accordance with Symantec’s posted privacy policy found at www.symantec.com.

4. Fees. The Service is currently provided without charge to You. Symantec may change its fees and payment policies for the Service from time to time by updating this Terms of Service.
5. Ownership/Title. Symantec and its licensors retain any and all rights, title and interest in and to the Software and Service, including in all copies, improvements, enhancements, modifications and derivative works thereof.

9. **Survival.** The following provisions of this Terms of Service survive termination of this Terms of Service: License Restrictions and any other restrictions on use of intellectual property, Ownership/Title, Warranty Disclaimers, Limitation of Liability, Survival, and General.
10. **General.**
 - a. **Compliance with Applicable Law.** You are solely responsible for Your compliance with, and You agree to comply with, all applicable laws, rules, and regulations in connection with Your use of the Service and/or Software.
 - b. **Governing Law.** If You are located in North America or Latin America, this Terms of Service will be governed by the laws of the State of California, United States of America. Otherwise, this Terms of Service will be governed by the laws of England. Such governing laws are exclusive of any provisions of the United Nations Convention on Contracts for Sale of Goods, including any amendments thereto, and without regard to principles of conflicts of law. If any provision of this Terms of Service is found partly or wholly illegal or unenforceable, such provision shall be enforced to the maximum extent permissible, and remaining provisions of this Terms of Service shall remain in full force and effect. A waiver of any breach or default under this Terms of Service shall not constitute a waiver of any other subsequent breach or default.
